# **Application**

#### Area of application

Styrofan® 7528 is mainly used to modify hydraulic binders, especially cement mixtures. It is mainly employed in products that have to meet the high standard of mechanical properties, such as flexible waterproofing (WP) membrane, rigid WP mortar and so on. Trials must be performed in advance for each specific application, because the performance of Styrofan® 7528 is influenced to a large extent by the type of hydraulic binder involved.

#### **Processing**

Customers have to carry out their own trials when developing and processing products based on Styrofan® 7528. The compatibility of Styrofan® 7528 with other ingredients of formulations, mixing processes, and its adhesion on different substrates, etc., are affected by a variety of factors which are too numerous for us to take into account in our own trials. This also includes testing the stability of its viscosity when it is stored at temperatures of ca. 50 °C.

# Safety

#### General

The usual safety precautions when handling chemicals must be observed. In particular, the place of work must be well ventilated if large quantities are being processed, the skin should be protected, and safety glasses should be worn at all times.

#### **Safety Data Sheet**

A Safety Data Sheet has been compiled for Styrofan<sup>®</sup> 7528 that contains up-to-date information on all questions relevant to safety. Styrofan<sup>®</sup> 7528 can cause irritation to the skin and mucous membranes after prolonged exposure.

#### Labelling

According to all the data at our disposal, Styrofan<sup>®</sup> 7528 does not need to be labelled as a dangerous substance or preparation as defined in the relevant European Union directives (substances directive 1967/548/EC and preparations directive 1999/45/EC) according to their current status.

# **Storage**

Styrofan® 7528 has a shelf life of six months at 10 – 30 °C in tightly sealed containers.

Styrofan® 7528 is fully protected against microbial attack during transport, but we would recommend treating it with a biocide in order to prevent problems with microorganisms from occurring during storage and processing. Attention also needs to be paid to the hygiene of bulk storage facilities. Further details are given in our leaflet on "The handling and storage of polymer dispersions".

This product must not be allowed to come into contact with bare iron or copper and its alloys during storage.
